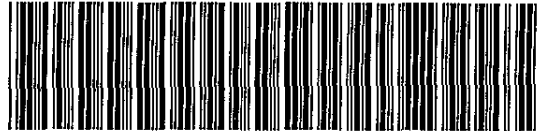

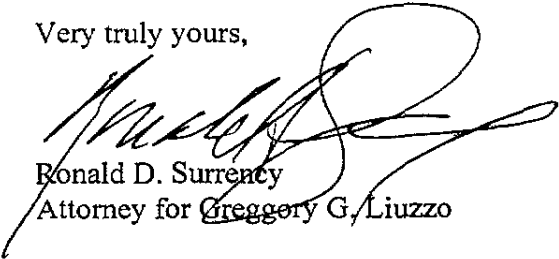

ARTICLE V - MANAGEMENT

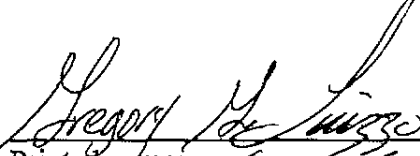

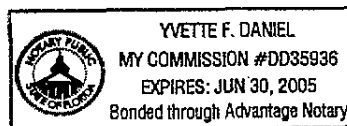

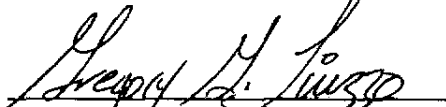
