#### ARTICLES OF ORGANIZATION OF

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a member of an authorized representative of a member of SONICA R. CINAMI, ESQ., L.L.C., hereby forms a limited liability company.

#### Article 1 - Name
