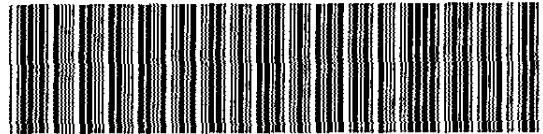

ARTICLES OF ORGANIZATION OF

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a member or an authorized representative of a member of SONICA R. CINAMI, ESQ., L.L.C., hereby forms a limited liability company.

Article 1 - Name

The name of the limited liability company is SONICA R. CINAMI, ESQ., L.L.C. (the "Company").

Article 2 - Duration

The duration of the Company shall be from the date of creation to and until September 25, 2036, unless sooner terminated or extended by agreement of the Members.

Article 3 - Initial Principal Office

Article 4 - Registered Agent

Article 5 - Additional Members

No person may be admitted as a member of the limited liability company except upon the unanimous written consent of the then existing members of the Company.

Article 6 - Continuation of Business Upon Termination of Member

In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall be continued, and the Company shall not be dissolved unless the remaining Members of the Company so elect.

Article 7 - Management

The affairs of the Company shall be managed by one or more Managers who shall be elected by and hold such offices as may from time to time be determined by the members of the Company. The ability of the Manager or Managers to bind the Company

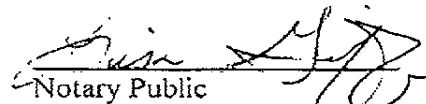

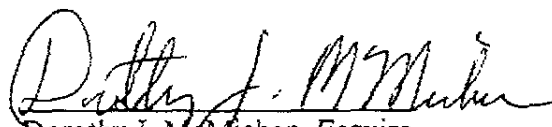
