

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The mailing address and street address of the principal office of the Company is 2600 Washington Road, Mt. Dora, Florida 32757


ARTICLE III – DURATION
