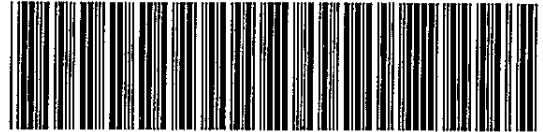

**Article I

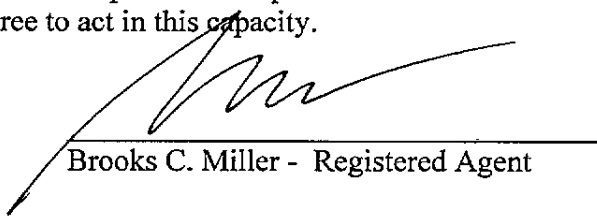
