AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR BLUE MOUNTAIN BEACH DEVELOPMENT, LLC.

The undersigned, being authorized to execute and file these Amended and Re Articles of Organization, hereby certifies that:

ARTICLE I - Name:
