**ARTICLES OF ORGANIZATION
FOR
CEO, L.C.**

ARTICLE I

The name of this Limited Liability Company is: CEO, L.C. (hereinafter referred to as the "Company").

ARTICLE II

The street address and mailing address of the principal office of the Company is: 6150 Whiskey Creek Drive, Fort Myers, Florida 33919-8745.

ARTICLE III

The period of duration for the Company shall begin as of the effective date for the filing of these Articles of Organization, and end on the sooner of (i) December 31, 2050 or (ii) the occurrence of any event which requires the dissolution of the Company as set forth in the Operating Agreement for the Company.
