MEMBERSHIP



MEMBERS' RIGHTS TO CONTINUE BUSINESS

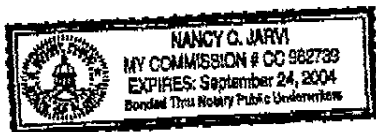
