



#### ARTICLES OF ORGANIZATION

## HOJC HOLDINGS, LLC

I, the undersigned, being of legal age and a natural person, do hereby subscribe to acknowledge and file the following Articles of Organization for the purpose of creating a limited liability company ("Limited Liability Company") under Chapter 608 of the Florida Statutes and the laws of the State of Florida.

#### ARTICLE I

The name of the Limited Liability Company is: HOJC HOLDINGS, LLC

# ARTICLE II

The mailing address and street address of the principal office of the Limited Liability Company shall be: 1200 N. Federal Highway, Suite 207, Boca Raton, Florida 33432, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the manager.

#### **ARTICLE III**

This Limited Liability Company may engage in any activity or activities permitted under the laws of the State of Florida.
