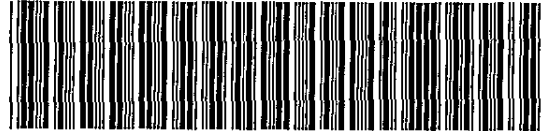

NAME

ARTICLE II

ARTICLE X


