**ARTICLES OF ORGANIZATION
OF
TITUSVILLE ASSOCIATES, LLC**

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE I - NAME

The name of this limited liability company shall be Titusville Associates, LLC (the "Company").


ARTICLE X - AMENDMENT
