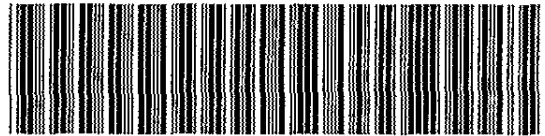

**ARTICLE I – NAME**

The name of the limited liability company is NORTHERN FIRST FUNDING, LLC ("Company").

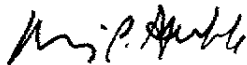
