

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I — Name

The name of the Limited Liability Company is Zebulon and 41, LLC.

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be as set forth in the Operating Agreement of the LLC.


ARTICLE VI — Members' Rights to Continue Business


The right, if given, of the remaining members of the limited liability company to continue


