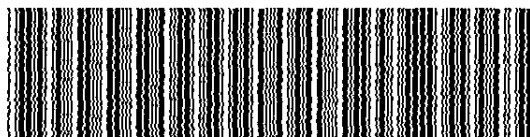

limited liability company, unless the remaining members shall unanimously agree to continue the business of the company, in which event, this company shall not so terminate.


#### ARTICLE VI - MANAGEMENT
