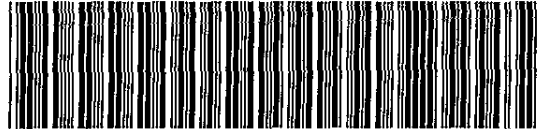

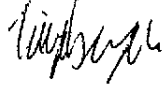

# ARTICLES OF ORGANIZATION

## FOR

### Med-IQ LLC

#### a Florida Limited Liability Company

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of organization for such company:

1. Name. The name of this company shall be:

2. Duration / Continuation. The period of this company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy, or dissolution of all members or upon the occurrence of any other event which terminates the continued membership of a member, unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the company subsequent to the foregoing events.

6. Management of Company. Management of the company is reserved to the members. The name and address of the Managerial member is:

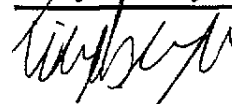
