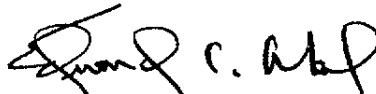

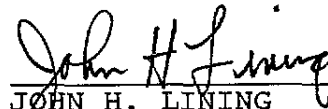

The Company shall be effective on August 11, 2003 and shall have perpetual duration.

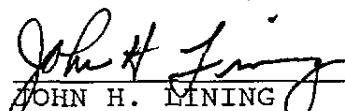
