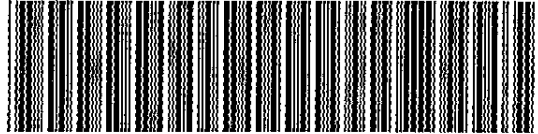



The name and the Florida street address of the initial registered agent are: Clifton A. Livingston, 201 East Davis Blvd., Tampa, Florida 33606.


ARTICLE IV — Management:

The Company is to be managed solely by one managing member. The initial managing member Clifton A. Livingston.


ARTICLE V — Limitation on Agency Authority of Members:
