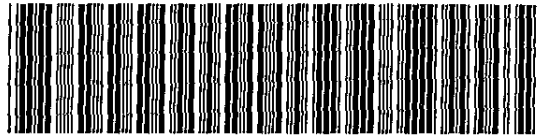



**ARTICLES OF ORGANIZATION OF  
SK PROPERTIES OF LAKELAND, LLC**


