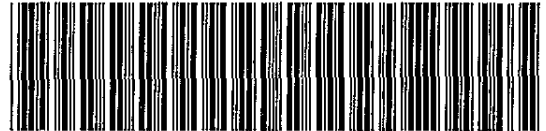

ARTICLES OF ORGANIZATION OF  
DUONG COMPANY, L.L.C.

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a member or an authorized representative of a member of DUONG COMPANY, L.L.C., hereby forms a limited liability company.

Article 1 - Name

The name of the limited liability company is DUONG COMPANY, L.L.C. (the "Company").

Article 2 - Duration

The duration of the Company shall be from the date of creation to and until January 31, 2012, unless sooner terminated or extended by agreement of the Members.

Article 3 - Initial Principal Office

The mailing address and the street address of the initial principal office of the Company shall be 382 W. Misty Hollow Drive, Jacksonville, Florida 32225.

Article 4 - Registered Agent

The name and address of the initial registered agent within the State of Florida for the Company is Thanh V. Duong, 10055 Atlantic Blvd., Jacksonville, Florida 32225.

Article 5 - Additional Members

No person may be admitted as a member of the limited liability company except upon the unanimous written consent of the then existing members of the Company.

Article 6 - Continuation of Business Upon Termination of Member

In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall be continued, and the Company shall not be dissolved unless the remaining Members of the Company so elect.

Article 7 - Management

The affairs of the Company shall be managed by one or more Managers who shall be elected by and hold such offices as may from time to time be determined by the members of the Company. The ability of the Manager or Managers to bind the Company without Member approval are limited by the terms of the Operating Agreement. The

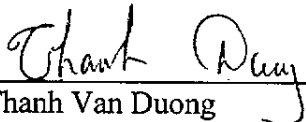

Article 8 - Initial Members

The number of members may be increased or diminished from time to time pursuant to the terms and conditions of the operating agreement, but shall never be less than one member. 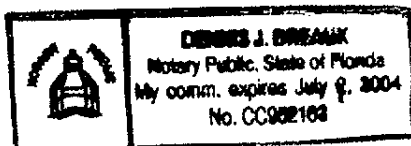

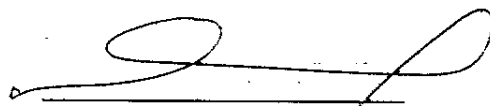

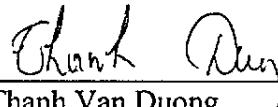
