ARTICLES OF ORGANIZATION OF

DUONG COMPANY, L.L.C.

OS NO 19 PAR DE 13 Pursuant to Chapter 608, Florida Statutes, the undersigned, being a member or an authorized representative of a member of DUONG COMPANY, L.L.C., hereby forms as limited liability company.

Article 1 - Name

The name of the limited liability company is DUONG COMPANY, L.L.C. (the "Company").

Article 2 - Duration

The duration of the Company shall be from the date of creation to and until January 31, 2012, unless sooner terminated or extended by agreement of the Members.
