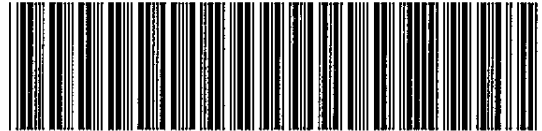

### CONSENT TO DISSOLUTION

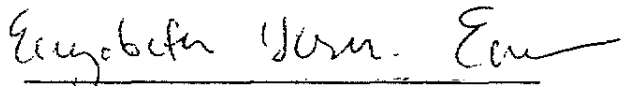
