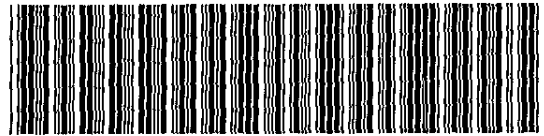

ARTICLE I - NAME

ARTICLE VI - MEMBERS' RIGHT TO CONTINUE BUSINESS

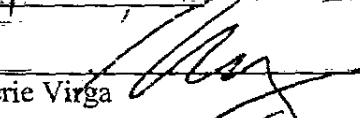

ARTICLE VII - MANAGEMENT

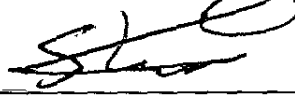
