**ARTICLE I: NAME**

The name of this limited liability company is TUGBOAT ADVENTURES, LLC (hereinafter "Company"), whose mailing address and street address of the principal office of the limited liability company is **1082 Bluewood Terrace, Weston, Florida 33327.**

**ARTICLE II: DURATION**

This limited liability company shall remain in existence perpetually; and the effective date of commencement is hereby designated as the date of filing of these Articles.
