#### ARTICLES OF ORGANIZATION

#### **ARTICLE I - NAME**

FILED PH 3 The name of the Limited Liability Company is: TFP ENTERPRISES, LL

#### ARTICLE II - ADDRESS

#### ARTICLE IV - MEMBER SHARES



#### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS
