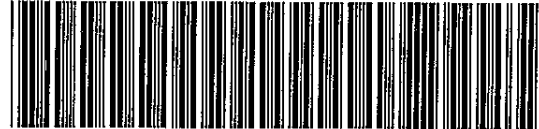



**ARTICLES OF ORGANIZATION
FOR

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

**ARTICLE I
(Name)**

The name of the limited liability company is David E. Fevez, LLC ("the Company").

**ARTICLE II
(Address)**

**ARTICLE III
(Duration and Continuation)**

(Additional Members)**


