**ARTICLES OF ORGANIZATION
OF
C.R. Enterprise, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under Chapter 608, Florida Statutes, the Florida Limited Liability Company Act.

Article 1 – Name

The name of the limited liability company is C.R. Enterprise, LLC, (the "Company").

Article 2 – Address

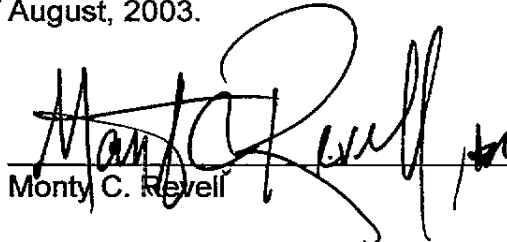
