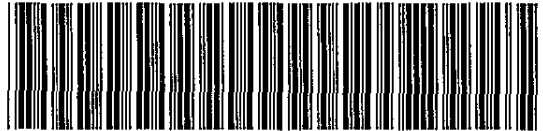

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes (1995) Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be TARPON BEND FOOD & TACKLE, CORAL GABLES LLC (the "Company"). The principal place of business and mailing address of the Company in Florida shall be 200 S. W. 2nd Street, Fort Lauderdale, Florida 33301.

ARTICLE II

DURATION
