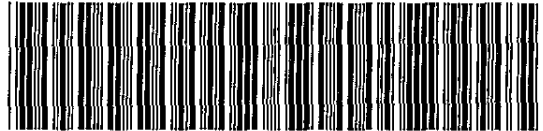


A) Article III be and it hereby is amended to read as follows:
