**ARTICLES OF ORGANIZATION  
OF  
ENVISION FOR NON PROFITS, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I**

**Name, Mailing Address and Purpose of Organization**

The name of this limited liability company is Envision for Non Profits, LLC (the "Company"). The Company's initial mailing and street address is 300 South Duncan Avenue Suite 237, Clearwater, Florida 33755-4200 and its initial registered agent is David M. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

**ARTICLE II**

**Duration of Existence**

#### Management of the Company


The Company shall be managed by one or Managers, who shall be elected annually by the Members in the manner set forth in the Company's Operating Agreement.




CERTIFICATE DESIGNATING
