**ARTICLES OF ORGANIZATION
OF

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I

NAME

The name of the Limited Liability Company is: **ATLANTIS PROPERTIES EMERALD COAST, LLC.**

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

The principal place of business of the Limited Liability Company is: 4042 Broken Arrow Court, Destin, Florida 32541.

ARTICLE III

REGISTERED OFFICE AND AGENT
