**FIRST:** The Articles of Organization were filed on August 25, 2003 and assigned document number L03000031739.

**SECOND:** The following amendment to the Articles of Organization were adopted by the limited liability company:

1. The name shall be changed to McClure & Loboizzo, a Professional Limited Company.
2. The Company shall be changed from a Limited Liability Company under Section 608, Florida Statutes to a Professional Limited Company under Section 621, Florida Statutes.
3. Article VI – Purpose, shall be added as follows:

**ARTICLE VI – Purpose:**


