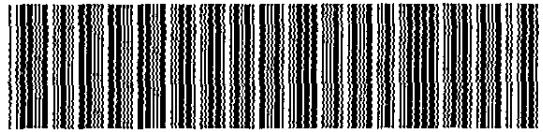

**ARTICLES OF ORGANIZATION
OF
LASALLE HOLDING COMPANY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be LASALLE HOLDING COMPANY, L.L.C. ("Company").

**ARTICLE II
PURPOSE AND POWER**


