

ARTICLES OF ORGANIZATION OF LASALLE HOLDING COMPANY, LLC

The undersigned, for the purpose of forming a limited liability company under Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, file the following Articles of Organization.

ARTICLE I

The name of the limited liability company shall be LASALLE HOLDING COMPANY, L.L.C. ("Company").

ARTICLE II PURPOSE AND POWER
