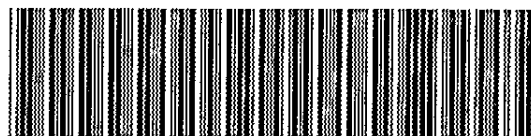

Article I. Name

The name of this Limited Liability Company is Crawford Groves, L.L.C.
