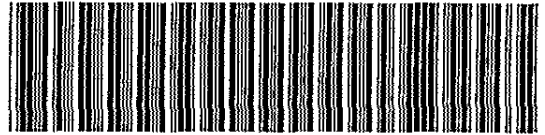

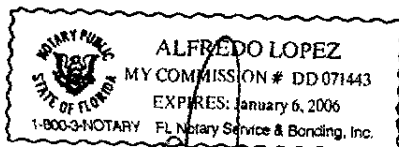

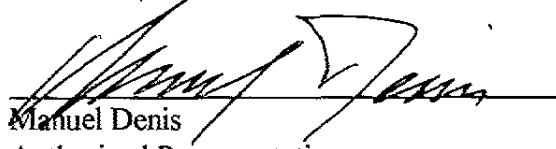
This company shall be managed by a Manager appointed in accordance with the Regulations and Operating Agreement of the Company.

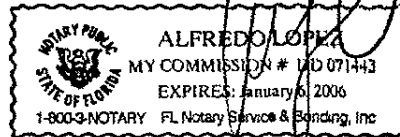

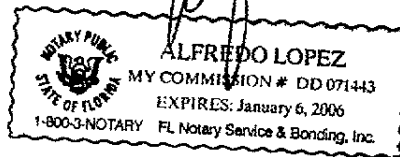
