**ARTICLE I

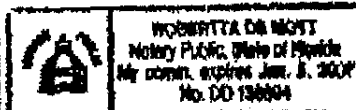

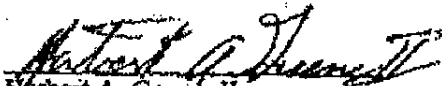
