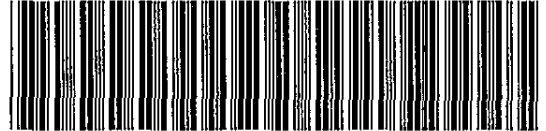

ARTICLE I — NAME:

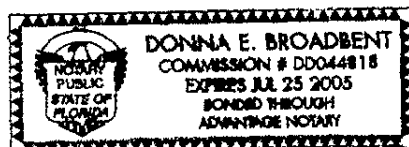

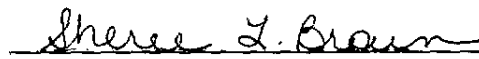

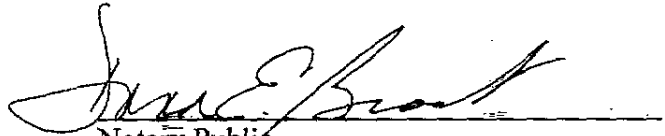
