

**ARTICLES OF ORGANIZATION
OF

Additional members may be admitted to the L.L.C. as set forth in the Operating Agreement.

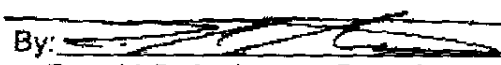
ARTICLE VII

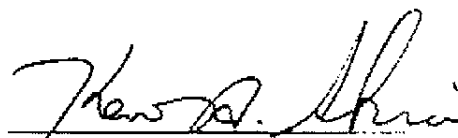

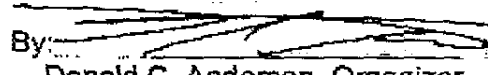

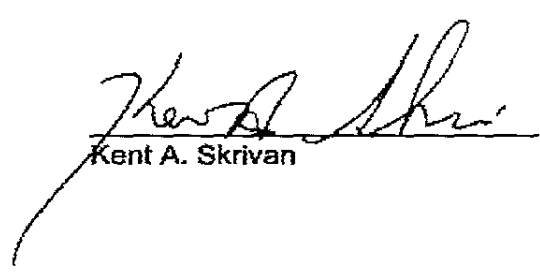
