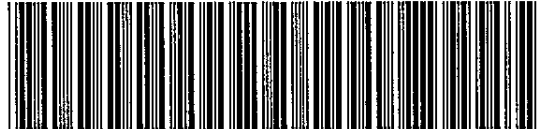

Organizer






