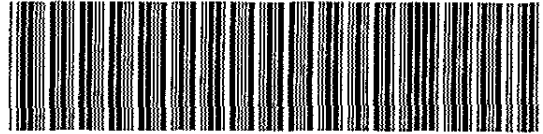

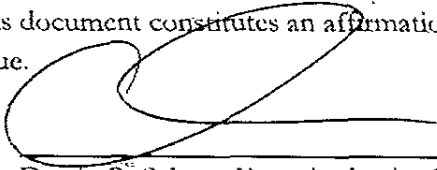
**ARTICLE VI

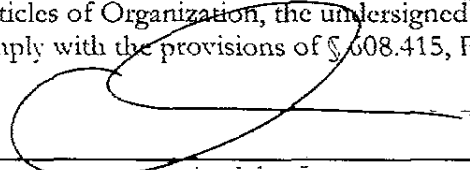
