Pursuant to the provisions of Chapter 608, *Florida Statutes*, the undersigned, The Allen Group (Florida), LLC, a Florida limited liability company (the "<u>Company</u>") hereby adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The date of filing of the Articles of Organization was August 28, 2003 and the Document Number assigned to the Company is L030000032488.

SECOND: The following amendments to the Articles of Organization were adopted by the limited liability company:

Article 1 of the Articles of Organization of the Company is hereby amended in its entirety to read as follows:
