ARTICLES OF ORGANIZATION OF THE ALLEN GROUP, LLC

- 1. Name. The name of this limited liability company is THE ALLEN GROUP, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

- 7. Operating Agreement. The members shall have the power to adopt, after, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
- 8. <u>Additional Members.</u> Additional members to the Company may be admitted, but only in accordance with the Operating Agreement of the Company.
