**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
FOR
ROBSKO HOLDINGS, LLC

The undersigned authorized representative of a Member of ROBSKO HOLDINGS, LLC (the "Company") hereby executes and adopts the following Amended and Restated Articles of Organization pursuant to Chapter 605, Section 605.411, Fla. Stat. under the Florida Revised Limited Liability Company Act which Amended and Restated Articles of Organization replace in their entirety the previously adopted Articles of Organization of Company filed with the Florida Secretary of State on AUGUST 29, 2003:

**"ARTICLE I

The Company shall be managed by one or more managers as provided in the Company's Operating Agreement and the initial manager of the Company shall be Rene Hofmann.

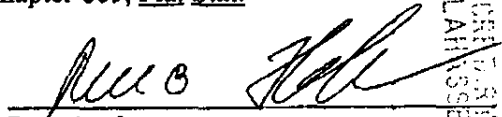
