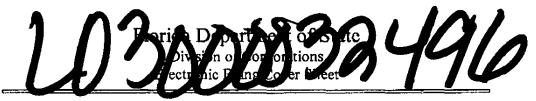

# AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR ROBSCO HOLDINGS, LLC A FLORIDA LIMITED LIABILITY COMPANY
