**ARTICLE I  
NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be ACROPOLIS ENTERPRISES, LLC, and the mailing address of its principal office shall be P.O. Box 7758, North Port, Florida 34287, and its street address is 3217 Morchester Lane, North Port, Florida 34286, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II  
PURPOSES AND POWERS**
