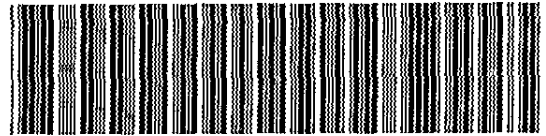

Miscellaneous

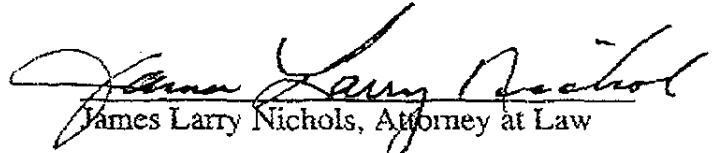
