

ARTICLE V -- MANAGEMENT



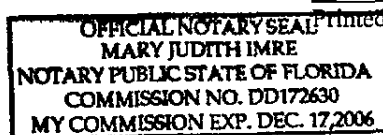


