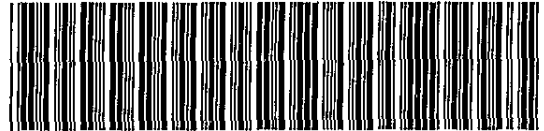


The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be solely upon the terms and conditions agreed upon by the initial members.
