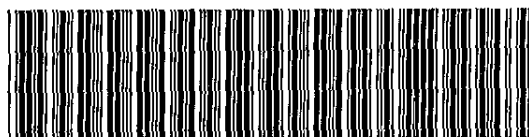

**ARTICLES OF ORGANIZATION OF
Bridge One, LLC**

ARTICLE I – Name:

The name of the Limited Liability Company is: Bridge One, LLC (the “Company”).


