**ARTICLES OF ORGANIZATION OF
WYATT R. TAYLOR, OPTOMETRIST, LLC**

The undersigned adopts the following articles of Organization for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act.:

ARTICLE I - NAME

The name of the Company is WYATT R. TAYLOR, OPTOMETRIST, LLC

ARTICLE II - INITIAL PRINCIPAL AND REGISTERED OFFICE AND AGENT

The street address of both the initial principal and registered office of the Company is 1502 South Jefferson Street, Perry, Florida 32348 and the name of the initial registered agent at such address is Wyatt R. Taylor. The Registered Agent has executed an acceptance in accordance with §608.415, Florida Statutes.

ARTICLE III- MEMBERS

The initial manager shall hold office for the first year of existence of the Company or until successors are elected or appointed and qualified, whichever occurs first.
